Usable & Unusable Cannabis	
Examples: seeds, stems, stalks, roots, immature buds, leaves, flower, raw pre-rolls. No concentrates or excipients added.	
Representative Sample Amount	0.5%
Minimum Compliance Weight	10g
Retention Sample Weight	20g
Batch Size	Minimum Number of Increments
<2.0 kg	4
2.1-3.0 kg	6
3.1-4.0 kg	8
4.1-5.0 kg	10
5.1-6.0 kg	12
6.1-7.0 kg	14
7.1-8.0 kg	16
8.1-9.0 kg	18
9.1-10.0 kg	20
10.1-11.0 kg	22
11.1-12.0 kg	24
12.1-13.0 kg	26
13.1-14.0 kg	28
14.1-15.0 kg	30

MAX BATCH SIZE: 15,000g / 33.07lb.

SAMPLE SIZE: 0.5% of batch / 10g

RETENTION SIZE: 20g

KEY POINTS:

- Reduction in maximum batch size.
- Raw pre-rolls must be within the pre-roll wrap prior to sampling.
- Usable & unusable cannabis is sampled in bulk form, prior to packaging.
- Significant reduction from NJAC 17:30 for retention sample size.
- Unusable and usable cannabis intended for manufacturing must be tested for contaminants prior to extraction.

Concentrates, Vapes & Infused Usable Cannabis	
Examples: Cannabis extracts, resin, rosin, shatter, bubble hash, inhalable oil, RSO, distillate, vapes, infused pre-rolls, inhalers.	
Representative Sample Amount	See Below
Minimum Compliance Weight	6g / 8g for Vapes
Retention Sample Weight	10g in at least 2 packages
Lot Size	Minimum Number of Units
<2.0 kg	4
2.1-3.0 kg	6
3.1-4.0 kg	8
4.1-5.0 kg	10

MAX LOT SIZE: 5,000g / 5kg

SAMPLE SIZE: 4-10 Units / 6g; 8g for Vapes

RETENTION SIZE: 10g / 2 packages

KEY POINTS:

- Reduction in maximum lot size.
- 1 unit = 1 vape cartridge/syringe/infused pre-roll/etc.
- Concentrates are required to be in final packaged form prior to sampling.
- Inhalable oils such as vapes are required to be within the inhalation device (ex. vape cartridge or inhaler) prior to sampling.
- Only whole packages will be taken for sampling. Packages cannot be opened.
- Significant reduction from NJAC 17:30 for retention and compliance sample sizes.

Solid Ingestible (Edible) & Solid Transmucosal Cannabis Products	
Examples: gummy, edibles, tablet, pill, lozenge, dissolving strip, suppository.	
Representative Sample Amount	See Below
Minimum Compliance Weight	10g
Retention Sample Weight	20g in at least 2 packages
Lot Size	Minimum Number of Units
1-500 Units	13
501-1,200 Units	20
1,201-10,000 Units	32
10,001-35,000 Units	50

MAX LOT SIZE: 35,000 units

SAMPLE SIZE: 13-50 units / 10g

RETENTION SIZE: 20g / 2 packages

KEY POINTS:

- Reduction in maximum lot size.
- 1 unit = 1 lozenge/gummy/edible/tablet/etc.
- Products must be in final packaging prior to sampling.
- Only whole packages will be taken for sampling. Packages cannot be opened.
- Significant reduction from NJAC 17:30 for retention and compliance sample sizes.

Dermal, Liquid Ingestible (Edible) & Liquid Transmucosal Cannabis Products	
Examples: tinctures, lotion, balm, patch, salve, topical formulation, nasal spray, beverage, syrup, drops, oral suspension.	
Representative Sample Amount	See Below
Minimum Compliance Weight	10g
Retention Sample Weight	20g in at least 2 packages
Lot Size	Minimum Number of Units
1-100 Units	2
101-500 Units	4
501-1,000 Units	6
1,001-5,000 Units	8
5,001-10,000 Units	10

MAX LOT SIZE: 10,000 units

SAMPLE SIZE: 2-10 units / 10g

RETENTION SIZE: 20g / 2 packages

KEY POINTS:

- Reduction in maximum lot size.
- 1 unit = 1 tincture bottle/balm/beverage/etc.
- Products must be in final packaging prior to sampling.
- Only whole packages will be taken for sampling. Packages cannot be opened.
- Significant reduction from NJAC 17:30 for retention and compliance sample sizes.
